

#### TERMS AND CONDITIONS FOR THE WEBSITE

THIS IS AN ELECTRONIC RECORD IN THE FORM OF A USER AGREEMENT FORMED UNDER THE ACT (DEFINED HEREIN BELOW) AND OTHER STATUTES PERTAINING TO ELECTRONIC DOCUMENTS / RECORDS. THIS USER AGREEMENT DOES NOT REQUIRE ANY PHYSICAL, ELECTRONIC OR DIGITAL SIGNATURE.

THIS USER AGREEMENT IS A LEGALLY BINDING DOCUMENT BETWEEN YOU AND EXIDE (BOTH TERMS DEFINED HEREIN BELOW). THE TERMS OF THIS USER AGREEMENT WILL BE EFFECTIVE UPON YOUR ACCEPTANCE OF THE SAME (DIRECTLY OR INDIRECTLY IN ELECTRONIC FORM, BY USE OF THE WEBSITE (DEFINED HEREIN BELOW) OR BY OTHER MEANS) AND WILL GOVERN THE RELATIONSHIP BETWEEN YOU AND EXIDE FOR YOUR USE OF THE WEBSITE.

THIS USER AGREEMENT IS PUBLISHED AND SHALL BE CONSTRUED IN ACCORDANCE WITH RULE 3(1) OF THE INFORMATION TECHNOLOGY (INTERMEDIARIES GUIDELINES) RULES, 2011 AND RULE 4 OF THE INFORMATION TECHNOLOGY (REASONABLE SECURITY PRACTICES AND PROCEDURES AND SENSITIVE PERSONAL DATA OF INFORMATION) RULES, 2011, THAT REQUIRE PUBLISHING OF THE USER AGREEMENT FOR COLLECTION, USE, STORAGE AND TRANSFER OF SENSITIVE PERSONAL DATA OR INFORMATION.

PLEASE READ THIS USER AGREEMENT CAREFULLY BY USING THE WEBSITE, YOU INDICATE THAT YOU UNDERSTAND, AGREE AND CONSENT TO THIS USER AGREEMENT. IF YOU DO NOT AGREE WITH THE TERMS OF THIS USER AGREEMENT, PLEASE DO NOT USE THIS WEBSITE. YOU HEREBY PROVIDE YOUR UNCONDITIONAL CONSENT OR AGREEMENT TO EXIDE UNDER SECTION 43A AND SECTION 72A OF THE ACT.

## A. DEFINITIONS

"Act" shall mean the Information Technology Act, 2000, as amended, modified or replaced from time to time and shall include the rules made thereunder.

"Content" shall have the meaning ascribed to it in clause 3.1 of the General Terms.

"Cookies" shall mean files that a user's web browser puts on such user's computer when a user visits a website. It is standard method of registering user preferences when people use Websites, to ensure a better and more personalized experience, which are stored in a file on a user's computer's hard disk drive.

**"Exide"** shall mean Exide Industries Limited and its subsidiaries and affiliates and associate companies. The terms "We" / "Us" / "Our" refers to each entity being part of the definition of Exide.

"Force Majeure Event" shall mean any event due to any cause beyond the reasonable control of Exide and/or the dealers, including, without limitation, acts of God, fire, flood, earthquake, explosion, civil commotion, strikes, lockout, and/or industrial action of any kind, riots, insurrection, hostilities whether war be declared or not, acts of government, governmental orders or restrictions, unavailability or breakdown of any communication system and/or transport facility, sabotage, breakdown and/or hacking of the Website and/or its features, software or contents provided for availing the services listed on the Website, such that it is impossible to perform the obligations under this User Agreement, or any other cause or circumstances beyond the control of Exide and/or the dealers hereto which prevents timely fulfilment of obligation of Exide and/or the dealers hereunder.

"General Terms" shall mean the terms of use in Part III herein.

"Non-Personal Information" shall have the meaning ascribed to it in clause 4.1 of the Privacy Policy.

"Personal Information" shall mean the data that can be used to uniquely identify or contact a single person, such as name, address, telephone number, email address, birth date and gender and the sensitive personal data or information as mentioned under the Act.

"Marks" shall mean trademarks, logos, service marks, etc.

"Privacy Policy" shall mean the privacy policy in Part I herein.

"Restricted Purpose" shall have the meaning ascribed to it in clause 1.4 of the General Terms.

"Terms of Use" shall mean the terms of use in Part II herein.

"User Generated Content" shall have the meaning ascribed to it in clause 12.1 of the General Terms.

"Website" shall mean the website with the domain name 'www.innovationchallenge.exideindustries.com'.

#### PART - I

#### **PRIVACY POLICY**

# 1. Acknowledgement

- 1.1. By providing us Your personal information (defined herein below) or by making use of the facilities provided by the website, You hereby consent to the collection, storage, processing and transfer of any or all of Your personal information and non-personal information (defined herein below) by Exide as specified under this User Agreement. You further agree that such collection, use, storage and transfer of Your personal information and non-personal information shall not cause any loss or wrongful gain to You or any other person.
- 1.2. You hereby agree to grant Exide a non-exclusive, worldwide, perpetual, irrevocable, royalty-free, sub-licensable right to exercise the copyright, publicity, and database rights (but no other rights) that You have in your Personal Information, to enable Exide to use the information in accordance with this User Agreement.

## 2. Authenticity of Information

- 2.1. The Personal Information provide by You to Exide from time to time is and shall be authentic, correct, current and updated and You undertake that You shall have all the rights, permissions and consents as may be required to provide such Personal Information to Exide.
- 2.2. Exide and each of its entities officers, directors, contractors or agents shall not be responsible for the authenticity of the Personal Information that You or any other user provide to Exide. You shall indemnify and hold harmless Exide and each of its entities officers, directors, contracts or agents and any third party relying on the Personal Information provided by You in the event You are in breach of this Privacy Policy including this Clause.

## 3. **Personal Information**

- 3.1. Personal Information is collected at the time of registration on the Website and/ or by subscribing to / availing our Services. We may also receive Your Personal Information from our business partners and other third parties, provided that such third parties confirm to us that You have permitted them to share such information.
- 3.2. Personal Information provided by You is used only:
  - 3.2.1. to facilitate Your use of the Website;
  - 3.2.2. to respond to Your inquiries;
  - 3.2.3. to provide You with information and offers about Exide's Services;
  - 3.2.4. to send You important information regarding the Website, changes to Exide's terms, conditions and policies and/or other administrative information;
  - 3.2.5. to send You surveys and marketing communications that Exide believes may be of interest to You;
  - 3.2.6. to personalize Your experience on the Website and Exide's other websites by presenting and advertising, products and offers tailored for You;
  - 3.2.7. to help You address issues with the Website including any technical problems;
  - 3.2.8. for proper administration of the Website;
  - 3.2.9. to conduct internal reviews and data analysis for the Website;
  - 3.2.10. to improve the services, content and advertising on the Website;

- 3.2.11. to protect the integrity of the Website; and
- 3.2.12. to respond to judicial process and provide information to law enforcement agencies or in connection with an investigation on matters related to public safety, as permitted by law.
- 3.3. Your Information will primarily be stored in electronic form. However certain data can also be stored in physical form. We may store, collect, process and use Your data in countries other than Republic of India, in compliance with applicable laws.
- 3.4. If You send Us personal correspondence, such as emails or letters, or if other users or third parties send Us correspondence about Your activities or postings on the Website, we may collect such information into a file specific to You.
- 3.5. You can always choose not to provide information and in such cases, if the information required is classified as mandatory, You will not be able to avail of that part of the Services, features or content.
- 3.6. You can add or update Your Personal Information on a regular basis. Exide may keep a copy of the prior version of your Personal Information for its records.

#### 4. Non-Personal Information

- 4.1. When You visit the Website, We automatically receive certain information of anonymous nature, such as Your internet protocol (IP) address, the domain You may have used to access Our Website, the type and version of browser or operating system You may be using, the content of any undeleted Cookies that Your browser previously accepted from Us and the Website You may have come from and visit next ("Non-Personal Information"). Such Non-Personal Information may be stored in server logs and does not assist Exide in identifying You personally.
- 4.2. This Non-Personal Information may include:
  - 4.2.1. Your geographic location;
  - 4.2.2. details of Your telecom service provider or internet service provider;
  - 4.2.3. type of browser (Internet Explorer, Firefox, Opera, Google Chrome etc.);
  - 4.2.4. operating system of Your system, device and the Website You last visited before visiting the Website; and/or
  - 4.2.5. duration of Your stay on the Website in each session along with the date and time of Your access.
- 4.3. We may also aggregate Your Non-Personal Information from the Website, such as demographic statistics, number of visitors and average time spent on the Website for our internal purposes.
- 4.4. Exide may use third-party service providers to serve advertisements on Exide's behalf across the internet and sometimes on the Website. They may collect Non-Personal Information about Your visits to the Website and Your interaction with Our dealers in relation to Our products and Services on the Website.

## 5. Cookies

5.1. To facilitate and customize Your experience with the Website, We may store Cookies on Your computer. We may use Cookies to record how often You visit our Website, and what

pages You go to on Our Website. The Cookie itself does not have Personal Information in it. We use Cookies to save Your time while using the Website, by reminding Us who You are, and track and target Your interests in order to provide You a customized experience. Use of this information helps us to create a more user-friendly experience for users.

- 5.2. You can choose to accept or decline Cookies. You can also erase or choose to block these Cookies from Your computer. Most web browsers automatically accept Cookies, but You can usually modify Your browser setting to decline Cookies. This may, however, prevent You from taking full advantage of the Website.
- 5.3. Other tracking technologies may record information such as internet domain and host names, internet protocol (IP) addresses, browser software and operating system types, stream patterns, and dates and times that the Website is accessed. Our use of Cookies and other tracking technologies allows Us to improve Our Website and Your experience.

# 6. **Purpose and Use of the Information**

- 6.1. The information provided to Us/ collected by Us is used for the purpose of providing You with Our Services, responding to Your inquiries and/or fulfilling Your requests for information about various services offered by Us, sending You important information regarding the Website and our Services, sending You emails the We feel may be of interest to You, personalizing Your experience on the Website by presenting advertising, products and offers tailored to Your requirements, properly administering the Website, conducting internal reviews and data analysis for the Website, improving our services, content and advertising on the Website and as required under law.
- 6.2. Personal Information and Non-Personal Information may be treated differently under this Privacy Policy.
- 6.3. In accordance with clause 3 herein above, the collection of Personal Information shall be limited to that which is necessary for the purposes identified by Exide. We will only use the information we collect about You lawfully and in accordance with the Act, relevant rules and other applicable laws of India. Exide does not trade or sell Your Personal Information without Your consent in any manner, except as specified in this Privacy Policy.
- 6.4. We use Your personal information to resolve disputes; troubleshoot problems; help promote a safe service; collect money; measure consumer interest in our products and services, inform You about online and offline offers, products, services, and updates; customize Your experience; detect and protect us against error, fraud and other criminal activity; enforce our terms and conditions; and as otherwise described to You at the time of collection.
- 6.5. To the extent that We use Your Personal Information to market to You, We will provide You the ability to opt-out of such uses.
- 6.6. In accordance with clause 4 herein above, Non-Personal Information is used by Exide to understand the use and number of users visiting the Website. Non-Personal Information may be shared with the sponsors, investors, advertisers, developers, associates, third-party service providers and strategic business partners of Exide in order to enhance and grow its business.
- 6.7. Exide may also use the log file, which is a standard measure. They include internet protocol

- (IP) addresses, browser type, internet service provider, referring/exit pages, platform type, date/time stamp, and number of clicks. Exide may use them to analyse trends, administer the Website, track users' movement and gather broad demographic information for aggregate use. IP addresses, etc. are not linked to Personal Information.
- 6.8. In our efforts to continually improve Our product and Services, we collect and analyse demographic and profile data about Our users' activity on Our Website. We identify and use Your IP address to help diagnose problems with Our server, and to administer Our Website. Your IP address is also used to help identify You and to gather broad demographic information.

# 7. **Sharing of Information**

- 7.1. Exide implements standard measures to protect against unauthorized access to and unlawful interception of Personal Information. However, no internet site can fully eliminate security risks.
- 7.2. We do not sell, rent, trade or exchange any of Your Personal Information. We may provide Your information to our affiliates and service providers under confidentiality agreement (such as customer care, data analytics) to support the operation of the Website and our Services.
- 7.3. We may share Personal Information with Our other corporate entities and affiliates. These entities and affiliates may market to You as a result of such sharing unless You explicitly optout
- 7.4. We may enter into agreements with third parties (in or outside of India) to store or process Your information or data. These third parties may have their own security standards to safeguard Your information or data and we will on commercial reasonable basis require from such third parties to adopt reasonable security standards to safeguard Your information / data.
- 7.5. Such disclosure to third parties may be required for Us to provide You access to Our Services, to comply with Our legal obligations, to enforce Our this User Agreement, to facilitate Our marketing and advertising activities, or to prevent, detect, mitigate, and investigate fraudulent or illegal activities related to Our Services. We do not disclose Your Personal Information to third parties for their marketing and advertising purposes without Your explicit consent.
- 7.6. Non-Personal Information may be shared with third-party service providers and other entities to serve advertisements on Exide's behalf across the internet and sometimes on the Website and assist Exide in growing its business on the Website.
- 7.7. We may share/sell some or all of Your Personal Information with another business entity should we (or our assets) merge with, or be acquired by that business entity, or reorganization, amalgamation, restructuring of business. In the event such a transaction occurs, the other business entity (or the new combined entity) will be bound by this Privacy Policy with respect to Your Personal Information.
- 7.8. In addition, Your Personal Information may be disclosed to the following third parties:
  - 7.8.1. to an associate or affiliate person;
  - 7.8.2. where it is necessary to enable any of Our staff, employees, agents, contractors,

suppliers or commercial partners to provide a service to Us or to perform a function on Our behalf (including providing marketing assistance, market research or customer services; and administering Your membership, supplying products or services that we provide to You now or in the future, or any free prize draws, prize competitions or promotions);

- 7.8.3. to Our professional advisers; or
- 7.8.4. where it is necessary in order to pursue Our legitimate interests or if We are required to or are permitted to do so by law.
- 7.9. We may disclose Personal Information about You to third parties or government authorities if we are legally obligated to or we believe that such a disclosure is reasonably necessary to (i) take action regarding suspected illegal activities; (ii) enforce this User Agreement; (iii) comply with legal process or other government inquiry, such as a search warrant, summon, statute, judicial proceeding, or other legal process/ notice served on us; (iv) protect Our rights, reputation, and property, or that of Our users, affiliates, or the general public; (v) respond to claims that any such data violates the rights of others; or (vi) protect the rights, property or personal safety of Exide, its employees, users of, or visitors to, the Website, and the public.
- 7.10. Exide may disclose any information Exide may have about You if Exide determines that such disclosure is necessary in connection with any investigation or complaint regarding Your use of the Website, or to identify, contact or bring legal action against someone who may be causing injury to or interference with (either intentionally or unintentionally) Exide's rights or property, or the rights or property of users of the Website, including Exide's customers.
- 7.11. You acknowledge that apart from Your Personal Information, if You upload any content on the Website, such content may contain Personal Information and the same may be available to the other users of the Website. Exide will not be liable for the disclosure and dissemination of such Personal Information to third parties.

#### 8. Data Retention

- 8.1. We retain the Personal Information while Your account is in existence or as needed for providing You with our services.
- 8.2. Exide may retain Your Personal Information even after You have closed Your account, if retention is reasonably necessary to comply with our legal obligations, meet regulatory requirements, resolve disputes, prevent fraud and abuse, or enforce this Privacy Policy and our Terms of Use.

#### 9. **Review of Information**

- 9.1. Your Personal Information can be reviewed by You by logging into Your account through Our Website.
- 9.2. The Personal Information provided by You, which is found to be inaccurate or deficient, can be corrected or amended by You online or by Us upon receipt of a written request from You in this regard. Exide shall not be responsible for authenticity of the Personal Information or other information supplied by You.
- 9.3. Non-Personal Information will be retained indefinitely.

#### 10. Links to Other Websites

- 10.1. The Website provides third-party advertisements and links to other websites. Exide does not provide any Personal Information to these third-party websites or advertisers and is not responsible for the privacy practices or the content of those linked websites. Accordingly, Exide does not make any representations concerning the privacy practices or policies of such third parties or terms of use of such websites.
- 10.2. The information provided by You to such third party Websites shall be governed in accordance with the privacy policies of such Websites and it is recommended that You review the privacy policy on any such Websites prior to using such Websites.

## 11. Security Precautions

- 11.1. Exide strives to ensure the security, integrity and privacy of Your Personal Information and to protect Your Personal Information against unauthorized access or unauthorized alteration, disclosure or destruction. For this purpose, Exide adopts internal reviews of the data collection, storage and processing practices and security measures, including appropriate encryption and physical security measures to guard against unauthorized access to systems where Exide stores Your personal data.
- 11.2. Exide may share Your Personal Information with third parties under a confidentiality agreement which *inter alia* provides for such third parties not disclosing the Personal Information further, unless such disclosure is for the purpose of providing Services. However, Exide is not responsible for any breach of security or for any actions of any third parties that receive Your Personal Information. Exide is not liable for any loss or injury caused to You as a result of You providing Your Personal Information to third party (including any third party Websites, even if links to such third party Websites are provided on the Website).

#### 12. Withdrawal of consent

- 12.1. By using the Website and/ or by providing Your Personal Information, You consent to the collection and use of such information by Exide. At any time while availing our Services or otherwise, You can withdraw Your consent for the collection and use of the Personal Information. Such withdrawal of the consent should be sent to Us in writing.
- 12.2. In case You do not provide Us with the Personal Information required for availing our Services or later on withdraw Your consent, We have a right not to provide You with Our Services and You shall not be authorized to visit/ use the Website.

## 13. Modification to Privacy Policy

13.1. If We decide to change Our Privacy Policy, We will post those changes on this page so that You are always aware of what information We collect, how We use it, and under what circumstances We disclose it.

## PART - II

#### **TERMS OF USE**

## 1. Eligibility to Use

- 1.1. Use of the Website is available only to persons who can form legally binding contracts under Indian Contract Act, 1872 and any other applicable law for this purpose. Persons who are 'incompetent to contract' within the meaning of the Indian Contract Act, 1872 or any other applicable law for this purpose including minors, un-discharged insolvents etc. are not eligible to use the Website.
- 1.2. Exide reserves the right to refuse access to use the Services offered at the Website to new users or to terminate access granted to existing users at any time without according any reasons for doing so.
- 1.3. You shall not have more than one (1) active account on the Website. Additionally, You are prohibited from selling, trading, or otherwise transferring Your account to another party.

## 2. User Obligations

- 2.1. Subject to compliance with this User Agreement, Exide grants You a non-exclusive, limited privilege to access and use this Website and the Services provided therein.

- 2.4. You agree not to access (or attempt to access) the Website and the materials or Services by any means other than through the interface that is provided by Exide. You shall not use any deep-link, robot, spider or other automatic device, program, algorithm or methodology, or any similar or equivalent manual process, to access, acquire, copy or monitor any portion of the Website, or in any way reproduce or circumvent the navigational structure or presentation of the Website, materials or any Content, to obtain or attempt to obtain any materials, documents or information through any means not specifically made available through the Website.
- 2.5. Exide disclaims all liabilities arising in relation to such offensive content on the Website. Further, You may report such offensive content in the manner prescribed herein.
- 2.6. If the Website allows You to post and upload any material on the Website, You hereby undertake to ensure that such material is not offensive and is in accordance with applicable laws.
- 2.7. You agree that You are solely responsible to Exide and to any third party for any breach of Your obligations under this User Agreement and for the consequences (including any loss or

- damage which Exide or its affiliates or its vendors may suffer) for any such breach.
- 2.8. You agree that Exide may, at any time, modify or discontinue all or part of the Website, charge, modify or waive fees required to use the Website, or offer opportunities to some or all Website users.

#### PART – III

#### **GENERAL TERMS**

### 1. Usage Conduct

- 1.1. You shall solely be responsible for maintaining the necessary computer equipment and internet connections that may be required to access, use and transact on the Website.
- 1.2. You are also under an obligation to use this Website for reasonable and lawful purposes only, and shall not indulge in any activity that is not envisaged in this User Agreement.
- 1.3. Exide shall be under no liability whatsoever in respect of any loss or damage arising directly or indirectly out of the decline of authorization for any transaction.
- 1.4. Exide grants you a personal, restricted, non-transferable, non-exclusive and revocable license to use the Website and the Services offered through the Website till the termination of this User Agreement according to the terms and conditions set forth herein. The Services are provided solely for Your personal and non-commercial use only ("Restricted Purpose").
- 1.5. You are permitted access to the Website and the Services solely for the Restricted Purpose and not for any other purpose whatsoever.

## 2. Representations, Warranties and Covenants

- 2.1. In addition to the representations and warranties mentioned in this User Agreement, You hereby represent and covenant to Exide that:
  - 2.1.1. the Information provide by You to Exide from time to time is and shall be authentic, correct, updated and You have all the rights, permissions and consents as may be required to provide such Information to Exide.
  - 2.1.2. Your providing the Information to Exide and Exide's consequent storage, collection, usage, transfer, access or processing of the same shall not be in violation of any third party agreement, laws, charter documents, judgments, orders and/or decrees.
  - 2.1.3. You will use the Website and the products for lawful purposes only. By using the Website, You agree to be in full compliance with all the applicable laws, rules, regulations and guidelines.
  - 2.1.4. You are a duly incorporated, established or registered, resident of India, as the case maybe, holding a permanent account number (PAN) in India.
  - 2.1.5. You are solely responsible for taking delivery of the products or any inconvenience or delay caused thereto, on account of Your inaccuracy or mistake, including but not limited to You providing Us with a wrong name or identity of Your authorized personnel taking delivery of the Products or any other incorrect information. You will indemnify Us for any losses incurred as a result of such inaccuracy or mistake.
  - 2.1.6. You will not interfere with the proper working of the Website, or with any other

- person's right to use this Website.
- 2.1.7. You are accessing this Website voluntarily and transacting at Your sole risk and are using Your best and prudent judgment before entering into any transaction through this Website including in relation to usage of the products.
- 2.1.8. You shall be responsible for checking product description and other related information before placing an order. By placing an order for a product You agree to be bound by the purchase order that may be issued by the dealer duly authorized by Us to provide Services through the Website.

- 3.1. - 3.3. Unless otherwise indicated or anything contained to the contrary or any proprietary material owned by a third party and so expressly mentioned, Exide owns all intellectual property rights to and into the trademark 'Exide', and the Website, including, without limitation, any and all rights, title and interest in and to copyright, related rights, patents, utility models, designs, know-how, trade secrets and inventions (patent pending), goodwill, source code, meta tags, databases, text, content, graphics, icons, and hyperlinks.
- 3.4. The Website and all the Content, graphic representations and images are the property of Exide. No part of the text, any graphics, images or Content on the Website may be reproduced or transmitted in any form or by any means, electronic, mechanical or otherwise, including by photocopying, facsimile transmission, recording, re-keying or using any information storage and retrieval system without Our prior written permission.
